They are:

Position #1-- XCEL Representative - this is a voting position and the person represents the XCEL program.

Position #2-- DP Representative - this is also a voting position and the person represents the DP program.

It is important to go onto the USA Gymnastics website and read the current minutes from the DP, XCEL,Tech and Admin. committees from this past May. There are decisions which will affect training this summer: Ex: moving up from Level 4, the Level 5 Bar dismount, individual event specialists, coach on the floor exercise, etc.

### Competitions

- USA Gymnastics has approved two items from the 2023 Women's Technical Committee meeting that will affect the judges' compensation package as stated in the *Women's Program Rules & Policies.* Starting **August 1, 2023**, the below items will be current:
  - Assigning fee: Increase of \$3.00 to \$5.00

• Any assigning fees collected prior to 8/1/23 will reflect the current \$3.00/per judge fee.

Any assigning fees collected 8/1/23 and after will reflect the new fee of \$5.00/per judge fee.

--- Judges hourly rate: Increase of \$1.00 per hour for all judges' ratings (Dev and Xcel)
